Health Support System



Medical Centre:

A healthy body and a sound mind are the mainstays of academic and personal excellence. For the benefit of students, the institute has a health centre that is operational 24x7 with additional 8 bed in-patient facility and an ambulance. Two resident doctors, one male and one female, are ably supported by qualified paramedical staff to ensure smooth operations. A specialist doctor makes weekly visits to the hostel. The institute also has a tie-up with AG Hospital, Tambaram, for emergencies.

Crescent Professional Counseling Centre

About Counselling:

- Therapeutic process that occurs when a client and counsellor set aside time in order to explore difficulties which may include the stressful or emotional feelings of the client.
- Helping the client to see things more clearly, possibly through different view-point. This can enable the client to focus on feelings, experience or behavior, with a goal to facilitating positive change.
- A relationship of trust. Professional counselor will usually explain their policy on confidentiality, they may, however, be required by law to disclose information if they believe that there is a risk to life.

Counselling and Psychotherapy:

- Both counseling and psychotherapy are terms that are used to describe the same process. Both terms relate to overcoming personal difficulties and working towards positive changes.
- Counselling is a helping approach that highlights the emotional and intellectual experience of a client, how a client is feeling and what they think about the problem they have sought help for.



- Whereas psychotherapy is based on the psychodynamic approach to counseling it encourages the client to recall past experiences and explore how these experiences affect their current 'problem'.
- A Psychotherapist therefore helps the client to become conscious of experience which they were previously unaware of. Counsellors ,however are less likely to be concerned with the past experiences of the client and are generally trained in a humanistic approach using techniques from client-centered therapy.

Role of Counsellor:

- The role of the counselor is to enable the client to explore many aspects of their life and feelings, by talking openly and freely.
- The counselor gives the client a liberty to express difficult feelings such as anger, resentment, guilt and fear in a confidential environment.
- Effective counseling reduces confusion, allowing the client to make effective decisions leading to positive changes in their attitude and / or behavior.
- The ultimate aim of counseling is to enable the client to make their own choices, reach their own decisions and to act upon them accordingly.

COVID-19 PREVENTIVE MEASURES & GENERAL HEALTH CHECK UP FOR ALL EMPLOYEES

As a part of COVID 19 Prevention, Medical Health Check Up was Initiated from 07-09-2020 to 18-09-2020 for all employees. They were checked for COVID 19 symptoms and suspected employees were sent for RT-PCR test and further follow up done for them.

Total Of 363 Employees were screened and various medical illness were identified. Detailed medical report was made.

- The students shall not possess/consume any narcotics or alcohol within the campus.
- Smoking in the campus is strictly prohibited
- The students shall not indulge in any act of indiscipline as defined in rules and regulations of the Crescent Institute of Science & Technology.
- Students shall not damage or destruct any Institute properties.
- Student shall not discriminate any other fellow student based on the caste, creed, language, and place of origin, social and cultural background.

IMPORTANT GUIDELINES FOR ALL STUDENTS

The following acts will be construed as acts of indiscipline and punishable under the Disciplinary rules of the Institute. Students are instructed not to get involved in any of these acts.

1. **<u>Ragging.</u>** Indulging in Ragging Activities or abetting ragging (As defined In the Ragging Act.)

<u>Dress Code.</u> Not adhering to the dress code (Male students: long hair, faded jeans, skin hugging clothing, T-shirts, Bermudas, short pants, Bathroom slippers, Track suit lowers, Different colour hair dyes, multi coloured apparels. Visible tattoos, ear studs, etc., are not permitted).

All students will wear shoes.

Female students are requested to wear Salwar Khameez /Kurta with Dhuppatta /head scarves in proper manner. Bathroom slippers are not permitted. No tight fitting cloth are allowed.

3. <u>**Display of Institute ID**</u>. Not wearing the Institute identity card within the campus in prescribed manner.

4. <u>**Punctuality.</u>** Coming late to class room, missing classes, remaining absent from classes for more than three days without prior information / permission. Staying in hostel room during Academic hours.</u>

5. Absence from Academic Activities. Unauthorisedly remaining absent

from the class, test or examination or any other curricular or co-curricular

Activity which he / she is expected to participate in. Leaving

Institute during working hours without valid permission.

6. **Examinations.** Indulging in copying or other malpractices in the Continuous Assessment Tests / End-Semester Examination / Substitute Examination / Practical Examination of the Institute.

7. <u>Unauthorised Activities.</u> Representation in intercollegiate seminars &
Cultural activities without permission. Unauthorized usage of the
Institute's name whilst planning/participating in private picnics / parties /
Get-togethers etc.

8. **Disruption**. Causing disruption in any manner in the academic Functioning of the Institute system like:-

(a) Loitering outside classroom,

(b) Behaving in rowdy, intemperate or disorderly manner in the Premises of the Institute as the case may be ,Encouraging or inciting Any other person to do so.

(c) Indulging in or encouraging any form of disruptive activity connected with tests, examinations or any other activity of the Institute or the School/ Department, as the case may be.

(d) Disturbing class room lectures/ Lab work by gossiping / making noise etc.

(e) Unruly / noisy behavior in organized events seminars /
 International Conference / convocation / events / placement seminar
 / admission seminar.

9. <u>Cyber Crimes.</u> Hacking Institute data center / sending obscene / communal/ hate/ messages with criminal intent.

<u>Use of Mobile Phones.</u> Usage of Mobile or any other form of mobile
 Communicating devices during academic hours in class rooms/ Labs /
 Examination Hall/ Auditorium.

11. <u>Unbecoming Conduct.</u> Misbehavior / disrespectful behavior, Physical assault or threat to use physical force against any member of the Teaching and Non-teaching staff of any School / Department / Institution, Security Staff , against fellow students and Police/public within or outside the premises of Crescent Institute of Science &Technology and its departments.

12. **Discrimination & Intolerance**. Creating discord, ill-will or intolerance Among the students on sectarian or communal grounds or inciting any Other student to do so; Discrimination against any student or a member Of staff on grounds of caste, creed, language, place of origin, social and Cultural back ground or any of these.

13. <u>Undesired Activities.</u> Smoking, use of narcotics, possession and
Consumption of alcoholic beverages. Use of drugs or other intoxicants
Except those prescribed by a qualified doctor. Gambling in any form.
14. <u>Any Act against Women</u> Any act whether verbal or otherwise
involving violation of the status, dignity and honour and is derogatory

to women. Eve Teasing, Accosting, Molesting, Using intemperate/abusive language, making suggestive obscene gestures, sending e mails/ what's app messages /MMS to female students or teachers.

15. **Indecent Behavior.** Indulging in mob driven misbehavior like whistling, cat calls, uttering obscenities etc.

16. <u>Violence / Protests.</u> Indulging in or encouraging violence or any Conduct which involves verbal abuse, mental or physical torture, aggression, corporal punishment, harassment, trauma, indecent and obscene gestures in particular students belonging to a scheduled caste or a scheduled tribe or other backward class. Any violation of the provisions of the Civil Rights ProtectionAct, 1976 is prohibited.

17. <u>Destruction/ Damage to Institute Property.</u> Willful destruction of the Property of the Institute or Departments. Writing obscenities on any wall / notice boards / sign boards of the Institute. Disfigurement / unauthorized removal of notices from Notice boards, disturbing of public signs etc.
18. Arms/ Weapons Carrying of, use of or threat to use of any

weapons.

19. **Hostel Rules**. Students staying in the Hostels are required to adhere to Hostel Rules and Regulations as given in the Undertaking which would be signed by them and their parents.

20. **Corruption**. Any attempt at bribing or corruption of any manner or description. Moral Turpitude. Thefts of Mobiles / Cameras/ Laptop / I pad or such like costly items, Two wheelers or four wheelers.

21. <u>Conduct in College Bus</u>. Misbehavior in the Institute bus even outside the Campus. Travelling in institute bus without valid pass Ragging in bus.

22. <u>Entry into the Hostel.</u> Day scholars are NOT permitted to enter hostels without prior permission of Warden/ Director Hostel.

23. <u>Assault/Affray/Arguments</u> Getting involved in arguments/assaulting/ misbehaving / using abusive language with Security staff/ Police/ Visitors to campus.
