Analysis on Feedback from Parents: Action Taken Report

- A. The various ways in which feedback from Parents were obtained during the Academic Year 2021-22:
 - Academic Association: Parents are acting as member of School Level Advisory Committee (SLAC) & Board of Studies (BOS) of the Departments. The SLAC and BoS were conducted in two sessions during December 2021 – January 2022 and June – August 2022.
 - In the academic year 2021-22, Parents Teacher meeting was conducted during the month of December (ODD semester 2021-22) in which around 2339 parents participated. During the Even Semester 2021-22, PTM was conducted in the month of may - june 2022, 556 parents were participated and gave their suggestions for holistic improvement of the Institution.
 - Online Feedback System through Institution website.

The salient suggestions taken forward for further course of action are:

- S1 emphasise to add advanced courses related to future automobile engineering.
- S2 more skill enhancement courses to crack down competitive exams
- S3 career development courses can be offered to succeed in the interview
- > S4 to offer more focussed placement training and industrial training.



B. Details of Action Taken

- S1: major revisions were carried in the core courses and new courses related to professional electives were introduced and approved in the 14th meeting of Board of Studies of Automobile Engineering Department and was deliberated in the 19th Academic council held on September 29th 2022.
- S2 was considered in the 2nd meeting of Board of Studies of Public Policy Department and new courses and elective courses were deliberated in the 18th academic council.
- S3 was considered in the 15th BoS of English and deliberated in the 19th Academic council vide agenda item no.19.18.3, 19.18.4.
- S4 : to enhance the students placement, The placement and training cell (PTC) and Industry Institute Partnership Cell (IIPC) conducted more number of training programmes, organised more number of webinar, employability assessment test, training for improving the aptitude, skills, reasoning ability across all the programmes. These training programmes ensured increase in number of students placement.
