

Technical Education - Starting of Saleh Kamel Crescent Engineering College at Othivakkam, Chengalpattu District by All India Islamic Foundation, Madras - Under self-financing scheme - Permission granted.

ORDER

In the Government Order first read above, the Government have approved the proposal for starting new Private Engineering Colleges in Tamil Nadu with effect from 1984-85, without involving any financial commitment both under recurring and non-recurring items of expenditure to the Government forever subject to the fulfilment of the conditions stipulated therein. The Director of Technical Education in his letter second read above has forwarded the proposal of the All India Islamic Foundation, Madras, with necessary documents and agreements in support of the proposal.

2. The Government after examining the proposal of the All India Islamic Foundation, Madras with reference to the orders issued in the Government Order first read above, permit the All India Islamic Foundation, Madras to start a private Engineering College in the name and style of "Saleh Kamel Crescent Engineering College" at Othivakkam, Chengalpattu District under self-financing scheme with effect from 1984-85, without involving any financial commitment to Government forever subject to the following conditions:-

(1) The following three degree courses shall be offered with the ultimate intake of 180 students per year (60 students in each course).

- (a) Civil Engineering
- (b) Mechanical Engineering
- (c) Electrical and Electronics Engineering

2. The All India Islamic Foundation, Madras can admit candidates of its choice upto 50% of the approved intake of the College under management quota. The candidates to be admitted under management quota should also fulfil the minimum educational qualification mark rules and age rules

scribed by the Government from time to time or its equivalent
or combination as approved by the University to which the College
is affiliated. The list of candidates so admitted should be
sent to the Director of Technical Education for his approval
in due course. Candidates to the remaining 50% of seats will be
selected by the Director of Technical Education from among the
approved list of candidates selected for admission to Government
or Government aided Engineering Colleges.

(3) The Saleh Kamel Crescent Engineering College, Othivakkan shall be affiliated to Madras University, Madras. The All India Islamic Foundation, Madras should also abide by the Rules and conditions prescribed by the Madras University besides the conditions stipulated in G.O.Ms.No.429/Education/dt.17.4.1984.

(4) The All India Islamic Foundation, Madras has already deposited a sum of Rs.12 lakhs (Rupees Twelve lakhs only) in the joint account of the Trust and the Director of Technical Education, Madras, towards the creation of an endowment of Rs.30 lakhs (Rupees Thirty lakhs only). The balance amount of Rs.18 lakhs (Rupees Eighteen lakhs only) should be deposited in instalments as ordered in para 2(4) of the Government order first read above.

(5) The All India Islamic Foundation, Madras has already furnished a sale agreement for 120 acres of land at Othivakkam, Chengalpattu District entered into with Seethakathi Trust for establishing the Saleh Kamel Crescent Engineering College. From out of this extent of 120 acres, a minimum extent of 75 acres and should be transferred to the All India Islamic Foundation, as, for establishing the Engineering College and necessary Transfer deed>Title deed should be produced to the Government within 15 days from the date of this order or before commencement of the classes of the College whichever is earlier. The Director of Technical Education is requested to obtain and forward the documents in this connection within the prescribed time. The remaining 75 acres of land should be purchased and documentary evidence produced in a period of two years.

(6) The staff recruitment should conform to the rules and orders issued by the Government for Government aided Engineering Colleges.

(7) The Workshops and Laboratories should be equipped every year as per the required standards to impart necessary practical training to the students.

(8) The Saleh Kamel Crescent Engineering College should be under the control of the Director of Technical Education, Madras and periodical review and inspection should be done by the Director of Technical Education.

(9) No additional course/increase in intake shall be allowed unless the Trust creates the endowment of Rs.30 lakhs (Rupees Thirty lakhs) in full.

(10) The All India Islamic Foundation, Madras should not collect capitation fee from the students seeking admission in the above college.

(11) Tuition fees and other fees should be collected from the students as in the case of Government Engineering Colleges or as directed by the Government from time to time.

(12) The building and other facilities shown by the All India Islamic Foundation, Madras in its letter dated 31.8.84 i.e., to make use of the facilities available in the Crescent Residential Higher Secondary School at Vandalur should be temporarily utilised to run the classes of the Saleh Khalif Crescent Engineering College. Permanent buildings and other facilities should be created exclusively for the Engineering College and the progress should be reported to the Government every year.

3. The Government also stipulate that if the above conditions are not fulfilled by the All India Islamic Foundation, Madras the permission granted is liable to be withdrawn at anytime and the Government will have the right to take over the Engineering Colleges at any time with all its immovable and movable properties including endowment and cash balance without paying any compensation.

4. This order issues with the concurrence of Finance Department vide its U.O.No.73/Additional Secretary/14 dated 15.9.1984.
